Dear Skaters / Members of SISA,

SISA, the US Embassy and Kallang Ice World, who has sponsored the ice, are working together to bring Michelle Kwan to Singapore.

SISA FIGURE SKATING WORKSHOP – January 10, 2011:

Michelle Kwan is currently scheduled to run a SISA figure skating workshop on January 10, 2011 from 4pm to 7pm at Kallang Ice World. She will do a demonstration/routine followed by on ice workshop for beginner level skaters all the way to elite skaters. Depending on the response and levels of skaters, we will allocate times accordingly. A tentative schedule for the workshop is as follows:

4:00 - 4:15	Michelle Kwan on ice for warm up / introduction
4:15 - 4:45	Beginner skaters / young children on ice with Michelle & 5 to 6 more experienced skaters/coaches. Run Learn to Skate Core 5 groups of 10 skaters - divided into skill groups for Core 1 to 4 (or adjust based on skill levels of registrants)
4:45 - 5:00	Conclusion of beginner session, Michelle has a break, takes pictures off ice with kids / autographs More experienced skaters on the ice for warm up
5:00 - 5:15	Michelle Kwan on ice for warm up / demonstration of skills / performance.
5:15 - 5:45	Future Star Level, Elementary skater workshop
5:45 - 7:00	Pre-Primary and above skater workshop

This workshop will be free for all SISA members. Skaters who are interested by not yet signed up as a SISA member should do so by 31st December 2010. Please see the attached SISA membership form. Note that you must also sign up as a member of one of the clubs under SISA.

Please spread the word. This is a great opportunity for anyone who has ever wanted to meet Michelle Kwan and has an interest in ice skating.

Michelle Kwan is the most decorated figure skater in US history and considered to be one of the greatest figure skaters of all time:

- two-time (1998 & 2002) Olympic Medalist;
- a five-time (1996, 1998, 2000, 2001 & 2003) World Champion;
- a nine-time (1996, 1998–2005) U.S. champion.
