NOTICE TO ALL SINGAPORE CITIZENS WHO INTEND TO PARTICIPATE AT THE SINGAPORE NATIONAL FIGURE SKATING CHAMPIONSHIP

IF YOU INTEND TO BE CONSIDERED FOR SELECTION INTO THE SINGAPORE NATIONAL OR DEVELOPMENT TEAMS TO REPRESENT SINGAPORE IN REGIONAL & INTERNATIONAL ISU EVENTS -

PLEASE FAMILIARISE YOURSELVES WITH **ISU COMMUNICATION 1420 AND ISU RULE 109** WHICH ARE ATTACHED TO THIS NOTICE. ADDITIONALLY, SISA ATHLETE SELECTION POLICY APPLIES (This policy is available from www.sisa.org.sg)

ISU Communication 1420 Section A (a) (ii) states that a clearance application must be submitted for

"any present citizen and skater of the Member who has in the past represented another ISU Member in an international competition and/or ISU Championships and whom the Member intends to enter in international competitions and/or ISU Championships in the coming season as a representative of the Member "

- As such, Singapore Citizen who intends to represent Singapore in international competitions or ISU Champions and who "in the past represented another ISU Member in an international competition and/or ISU Championships" and who now intends to represent Singapore must observe the clearance procedure mandated in ISU Communication 1420 and also observe the applicable waiting periods in section 2 (b) (ii) and (iii)
- Therefore, as a matter of clarity, SISA requires any Singapore citizen skater who
 has ever lived outside of Singapore, and who wishes to participate at the
 Singapore National Figure Skating Championships with the intention of being
 considered for selection into the Singapore National or Development Teams, is
 required to sign Skater's Declaration Form (Singapore Citizen) attached to this
 communication.
- Skaters who are Singapore citizens and who wish to seek clearance on ISU Rule 109 (2) (ii) and (iii) need to submit the following documents to reach SISA latest by latest by 5pm of 16th February 2012. SISA will consolidate all applications by the closing time of 16th February 2012 and submit them to ISU-
- 1) ISU Clearance Certificate application forms (see attached ISU communication no. 1420, pages 8-9)
- 2) a certified true copy of his/her passport
- a release letter obtained from the national skating association of the ISU country which he/she has represented at an International Competition and/or ISU Championships in the past.
