

Addendum to “33rd SOUTHEAST ASIAN (SEA) GAMES ATHLETES’ SELECTION POLICY (Short Track Speed Skating)”

This addendum is made on 13 August 2025, to the Selection Policy for the 33rd Southeast Asian (SEA) Games, approved by the Singapore National Olympic Council (SNOC), dated 14 August 2025.

On 6 August 2025, the Singapore Ice Skating Association (SISA) received the updated Technical Handbook (THB) from the SNOC. The THB reflects that the age requirement has been updated.

The purpose of this addendum is to update the following clauses:

Clause	
1.3	Ice Skating events at the 2025 SEA Games comprise of: <ul style="list-style-type: none"> (a) Short Track Speed Skating – Individual <u>Open</u> Women and Men 500m, 1500m (b) Short Track Speed Skating – <u>Open</u> Relay (Women <u>3000m</u>, Men <u>5000m</u>, Mixed <u>2000m</u>).
1.4	The quota places are as follow <ul style="list-style-type: none"> (a) Each NOC may enter a maximum of two (2) athletes per Individual event. (b) Each NOC may enter a maximum of one (1) team per relay event. <ul style="list-style-type: none"> (i) For Men and Women relay event, each NOC may enter a maximum of four (4) athletes each gender. (ii) For Mixed relay event, each NOC may enter a maximum of two (2) men and two (2) women.
1.6	Qualification Period - 3 December 2024 to <u>24 August 2025</u>
2.1 (a)	be a citizen of the Republic of Singapore (in accordance with ISU Communication <u>2526</u>);
2.1 (f)(i)	must be <u>15 years of age</u> and over (before 1 July 2025); and
2.1 (j)(ii)(5)	Level of commitment and attendance (i.e. maintain a level of fitness commensurate with that of an elite athlete – <u>commitment to training as deemed by the National Coach</u>).
3.2 (b)	Should any nominated athlete be unable to compete at the 33 rd SEA Games by reason of injury, illness or unforeseen reasons <u>prior to departure</u> , then the SISA Selection Panel may nominate a replacement Athlete for nomination to the SNOC from the reserve list.
3.2 (c)	For athlete replacements after the Entry By Name deadline, only athletes previously selected by SNOC selection or appeal committees can be considered as replacement athletes. Any replacements are subject to the conditions of late athlete replacement set by the event organiser.
4.1	Should any nominated athlete be unable to compete in the Southeast Asian Games 2025 for any reason then SISA may identify a replacement Athlete

	for nomination to the SNOC in accordance with Section 3 of this Nomination Criteria <u>prior to departure</u> .																												
4.2 (a)(iii)	For athlete replacements after the Entry By Name deadline, only athletes previously selected by SNOC selection or appeal committees can be considered as replacement athletes. Any replacements are subject to the conditions of late athlete replacement set by the event organiser.																												
5.2	Entries by name for the 33rd SEA Games will be submitted no later than <u>31 August 2025</u> or by the Appeals Deadline stipulated by SNOC. Nominations made after this deadline (or within such further deadline as the SNOC may allow) will be invalid.																												
7.3	Athletes must state in writing <u>via email</u> on their intention to appeal a selection decision by <u>23 August 2025, 23:59</u> , after the SISA's announcement of Athlete Nominations for the SEA Games 2025, accompanied by a PayNow screenshot of S\$200.00, payable to Singapore Ice Skating Association:																												
7.5	The Appeals Panel will convene and a decision will be made on <u>24 August 2025</u> .
