Notes:

1. Your donation will be used by SISA in accordance with the stipulated purpose in this form and in accordance with the Charities (Institutions of A Public Character) Regulations. By making the donation, you acknowledge and accept that once the donation has been made, SISA retains the sole right and discretion to determine how to apply the funds towards the stipulated purpose and to use said funds towards the stipulated purpose.
2. Only donations made towards the High-Performance Sports System will be eligible for the dollar-for-dollar matching grant under the OTSF Matching Grant scheme.

The One Team Singapore Fund (OTSF) is set up by Sport Singapore and the High-Performance Sport Institute (HPSI) to enable all Singaporeans and supporters of Team Singapore to play a part in grooming our next generation of sporting heroes. The High-Performance Sport ("HPS") System has contributed to the successes of Team Singapore and donations will be deployed to further enhance the HPS System.

To qualify for the OTSF Matching Grant Scheme, an NSA needs to receive cash donations for its HPS System. Donations from both corporate entities and individuals will be considered.

High Performance Sport ("HPS") projects and initiatives that will contribute to the HPS System includes:

- a. Pathway Development for Team Singapore athletes;
- b. Coach Development to raise the expertise and professionalism of coaches;
- c. Provision of Sports Science and Medicine services by the high performance sport institute;
- d. Enhancing the Training Environment for Team Singapore athletes locally or overseas;
- e. Data Analytics and Information to facilitate informed decision-making, improve sporting performance and enhance the efficiency of the sport;
- f. Management Capability to develop and implement clear multi-year sports plan.
- g. Competition Opportunities at the Regional, Continental, World/Olympics levels and their para equivalent,
- h. Community programmes that serve as a pipeline for Team Singapore athletes.
- i. HPS-related Manpower expenditure of National Sports Association ("NSA"), subject to an annual cap of Singapore Dollars One Hundred Thousand (S\$100,000) (i.e.: if NSAs can raise S\$100k in donations, they can receive a corresponding maximum matching amount of S\$100k through OTSF and use a total of S\$200k for NSA's HPS-related manpower costs).
